**MEMBERSHIP FEES – 2020**

- A) Seasonal**            -    \$70.00/ea
- B) Residential:**       -    \$100.00/ea
- C) Commercial:**     -    \$275.00/ea
- D) Contractor:**      -    \$100.00/ea

**NOTE:**

- A)** “RESIDENTIAL/SEASONAL” MEMBERS WILL BE ALLOWED TO DISPOSE OF THREE (3) HALF TON/TRAILER LOADS OF “PERSONAL” HOUSE/COTTAGE/YARD CLEAN-UP PER YEAR AT NO ADDITIONAL COST. ANY ADDITIONAL HALF TON/TRAILER LOADS WILL INCUR AN ADDITIONAL TIPPING FEE OF \$20.00/PER LOAD.
- B)** BOTH LANDFILL SITES ARE NOW OPERATING WITH FULL “RECYCLABLE” CAPABILITIES. PLEASE SORT/DEPOSIT ITEMIZED/APPROVED RECYCLABLES IN BINS PROVIDED – REFER TO THE RECYCLING SHEET IN YOUR POSSESSION & TABLET MARKINGS ATTACHED TO TOP RAILINGS OF RAMPS AT BOTH SITES.

**TIPPING FEES AND INTENT**

TIPPING FEES HAVE BEEN ESTABLISHED TO COMPENSATE FOR THE ADDITIONAL COSTS INVOLVED/ASSOCIATED IN OPERATING THE LANDFILL SITES. OPERATING COSTS FOR THE LANDFILL SITES INCREASE DUE TO THE REQUIREMENT OF HAVING THE SCRAP METALS REMOVED PERIODICALLY. IMPOSING A TIPPING FEE, IS DESIGNED TO OFFSET THESE COSTS BY HAVING THOSE MEMBERS WHO CONTRIBUTE TO THE “EXTRA” COSTS, PAY FOR THESE COSTS, RATHER THAN INCREASING “MEMBERSHIP FEES”, FOR ALL MEMBERS.

**TIPPING FEE STRUCTURE**

- A) REFRIGERATORS, FREEZERS (N/F), LARGE APPLIANCES, FURNACES - \$15.00/EA**
- B) REFRIGERATORS, FREEZERS, AIR CONDITIONERS (WITH FREON) - \$25.00/EA**
- C) FURNITURE - \$15.00/EA**
- D) MATTRESSES - \$20.00/EA**

- E) OIL TANKS (END CUT & FLUSHED) - \$20.00/EA
- F) PROPANE & WATER TANKS - \$10.00/EA
- G) PASSENGER, TRUCK, TRACTOR TIRE RIMS (ONLY) – NO CHARGE – TO BE PLACED IN METAL AREA.

NOTE: NO TIRES OF ANY SIZE WILL BE ACCEPTED

ADDITIONAL TIPPING FEES WILL BE IMPOSED ON ANY REFUSE COLLECTION BUSINESSES AND ROAD CREWS (INCLUDING MTO) BRINGING REFUSE OR MATERIALS TO THESE LANDFILL SITES. THE ADDITIONAL TIPPING FEES ARE “NEGOTIABLE” WITH THE DIRECTOR’S

MEMBERSHIPS ARE FOR “CALENDAR YEAR ONLY” – REGARDLESS OF WHEN PAID – CALENDAR YEAR IS JANUARY 1<sup>ST</sup> TO DECEMBER 31<sup>ST</sup>

MEMBER NOTICE

THESE LANDFILL DISPOSAL SITES ARE OPERATED BY THE "GOLDEN VALLEY/NORTH ROAD NON-PROFT LANDFILL INC." AND ARE FOR THE USAGE OF "PAID USER MEMBERSHIPS", ONLY.

- A) THESE ARE "YOUR" LANDFILL REFUSE DISPOSAL SITES. PLEASE MONITOR USERS & KEEP SITES SAFE & CLEAN. YOUR CO-OPERATION IS APPRECIATED. PLEASE REPORT ANY UNAUTHORIZED DUMPING/ACTS OF VANDALISM OR SUSPICIOUS ACTIVITIES TO THE SITE ATTENDANT(S) OR ANY MEMBER OF THE LANDFILL SITE DIRECTOR(S).
- B) UNAUTHORIZED DUMPING IS PROHIBITED UNDER SECTION 27 OF THE PUBLIC LANDS ACT R.S.O. 1990 AND IS SUBJECT TO A FINE OF NOT MORE THAN \$5,000.00 & WILL BE STRICTLY ENFORCED BY GOLDEN VALLEY/NORTH ROAD NON - PROFIT LANDFILL DIRECTOR(S), ON-SITE ATTENDANT(S) & THE MNR/MOE.
- C) THE CROWN AND ITS EMPLOYEES OR CONTRACTORS TAKE NO LIABILITY WHATSOEVER FOR ANY INJURY TO PERSONS OR ANY DAMAGE TO VEHICLES OR ATTACHMENTS (TRAILERS ETC.) RESULTING FROM THE USAGE OF THESE LANDFILL SITES.

SPECIAL NOTES

- (1) **BEWARE OF BEARS AT ALL TIMES – THEY ARE NOT TAME – DO NOT FEED OR APPROACH.**
- (2) ***Site(s) attendant(s) have full control of all the refuse/recyclable materials, dumping areas & right-of-ways & the “Member” agrees to abide by his/her instructions, at all times. Failure to do so may result in the cancellation of dumping privileges & will be requested to leave the landfill site immediately, which they must do so without hesitation. REFER TO THE ATTACHED CODE OF CONDUCT/RULES FOR MEMBERS***
- (3) Large refuse loads (NON CONSTRUCTION MATERIALS) are to be brought to the landfill site(s) a minimum of one half hour (1/2) before posted closing time. This allows the attendant(s) to close the facilities at the designated time(s). Failure to comply may result in the refusal of the load.
- (4) **NO SCAVENGING AT ANY TIME – WITHOUT ATTENDANT APPROVAL**
- 5) ALL LOADS BEING TRANSPORTED TO THE LANDFILL SITES ARE TO BE SECURED & TIED USING A TARPAULIN (OR SIMILAR METHOD) TO PREVENT REFUSE FROM BLOWING/FALLING OFF ON THE ROADWAYS – IT IS THE “LAW” & VIOLATORS MAY BE PROSECUTED & SUBJECT TO FINES.

**EFFECTIVE JANUARY 1, 2019:**

**MEMBER NOTICE**

**EFFECTIVE JANUARY 1, 2019,** THE FOLLOWING RECYCLABLES & REFUSE CHANGES WILL TAKE PLACE AT BOTH THE GOLDEN VALLEY/NORTH ROAD LANDFILL SITES:

- 1) NO “BRUSH, LOGS, STUMPS, PINE NEEDLES, BOATS OR PADDLE BOATS, HAZARDOUS WASTE , TIRES, OILS” WILL BE ACCEPTED AT ***EITHER*** SITE.
- 2) ALL MATTRESSES WILL BE BROUGHT TO THE “***NORTH ROAD SITE***” ***ONLY*** – FOR EASE OF DISASSEMBLE AT ONE LOCATION – DISPOSAL PRICE WILL INCREASE TO \$20.00/EA FOR 2019.
- 3) ***CONTRACTORS*** WITH LARGE REFUSE LOADS WILL USE THE ***GOLDEN SITE ONLY*** – MORE ROOM TO UNLOAD & DISPERSE.

- 4) **NO "USED OILS OF ANY TYPE"** WILL BE ACCEPTED AT **EITHER** SITE.
- 5) **NO "FLORESCENT LIGHT BULBS OF ANY TYPE"** WILL BE ACCEPTED AT **EITHER** SITE.
- 6) ALL ITEMS ARRIVING AT THE LANDFILL SITES, WILL BE DEALT WITH AS **RECYCLABLES OR REFUSE**.
- 7) FOR ANY ITEMS THAT STILL MAY HAVE LIFE OR CAN POSSIBLY BE USED BY SOMEONE ELSE, PLEASE TAKE SUCH ITEMS TO **"TRASH & TREASURERS"** FOR RESALE AS ALL PROCEEDS FROM TRASH & TREASURERS GO TO & BENEFIT OUR LOCAL **"FIRE DEPARTMENT"**.
- 8) FOR MEMBER USAGE, THERE IS A **"DIABETES DONATION CLOTHING"** BIN AT **BOTH** SITES FOR "CLOTHING ONLY" – SUPPORTS DIABETES PROGRAMS.
- 9) FOR MEMBER USAGE, THERE IS AN **"ELECTRONICS"** BIN AT **BOTH** SITES FOR THE ACCEPTANCE OF TELEVISIONS, RADIOS & VARIOUS OTHER ELECTRONICS (BASICALLY ANYTHING WITH A CORD) & BATTERIES (WHICH MUST BE STORED IN A PAIL/CONTAINER) NOT LOOSE.
